Project Sponsor Mission: The mission of the USDA Forest Service is to sustain the health, diversity, and productivity of the Nation's forests and grasslands to meet the needs of present and future generations.

Position Summary: In partnership with the Mt. Adams Institute, the Chattahoochee Oconee National Forests will be filling an Interdisciplinary Forestry Technician position on the Conasauga Ranger District in Chatsworth, Georgia. The Conasauga Ranger District is located about 90 miles north of Atlanta, GA and about 30 miles south of Chattanooga, TN. Because of the proximity to these population centers, the District has a very large and diverse recreation program which includes developed and dispersed recreation areas, and 290 miles of hiking/biking/equestrian/ATV trails. The District also contains the Cohutta Wilderness, which at 37,000 acres, is the largest and most heavily used Wilderness in the southeast. To help manage these resources, the District supports a nationally recognized volunteer program. This is primarily a field-going position that will focus on wilderness and trails management but will also participate in wildlife projects and other district priorities as they arise.

General Responsibilities (to include, but not limited to):

1. Promote responsible public land stewardship through informational visitor contacts and by being a positive role model.
2. Dispersed campsite management in the Cohutta Wilderness; including cleaning

- assessing, monitoring, rehab and decommissioning.
3. Visitor contacts to convey critical wilderness information.
 4. Trail maintenance and construction activities.
 5. Invasive species identification, survey and treatment.
 6. Wilderness Education activities including developing and presenting materials to a wide variety of audiences (school groups, special interest groups, informational booth at festivals etc.).
 7. Support of ongoing monthly trail volunteer activities.
 8. Assist with ongoing development and refining of wilderness character monitoring plans.
 9. Maintenance of developed and dispersed recreation areas (campgrounds, day use, trailheads etc.).
 10. Installation of in-stream fish structures.
 11. Assist with maintenance of wildlife openings (will require tractor operator certification).
 12. Complete a Community Action Project that is identified by the intern, researched, and implemented during the term of service.
 13. Attend and complete all MAI/AmeriCorps training and service requirements including orientation, trainings, team meetings and national service days.
 14. Complete and submit all necessary MAI/AmeriCorps paperwork and reports in a timely manner.
 15. Wear an MAI uniform and/or appropriate identifiers and required safety gear while performing service or attending official events.

Position Requirements:

1. Must have a valid driver's license, clean driving record and ability to provide documentation. Must comply with Driver Certification and Safety Agreement (see VetsWork Application Documents on website).
2. Attend a mandatory orientation in Dover, TN from 3/4 to 3/8 (food and lodging provided), intern trainings, and intern meetings.
3. Knowledge of basic computer programs.
4. Must be able to withstand the elements and work in rugged terrain: 80% or more of work is fieldwork.
5. Must become FirstAid/CPR certified (training will be provided if not currently certified).
6. Must complete Defensive Driving course (provided).
7. Ability to spend multiple days/nights in Wilderness and be self-reliant.
8. Good communication skills: must be comfortable relaying information in both formal and informal public contact settings.
9. Meet other requirements of federal employee (eg. background check, defensive driving, etc...)
10. Must have served in US Armed Forces and have a DD214 with an honorable discharge.
11. 21 years of age at beginning of service term.
12. U.S. citizen, national or lawful permanent resident.
13. Possession of a high school diploma or equivalent, or commit to earning one prior to receiving an education award.

14. Ability to commit to the full 45-week term of service.
15. Selection, placement and retention are contingent upon passing the National Sex Offender Public Register and a national FBI fingerprint check. Position does have recurring access to vulnerable populations.
16. Members are eligible to serve up to four terms of service and receive AmeriCorps Education awards for each term of service up to the value of two full time education awards only. It is the responsibility of the applicant to inform MAI of any previous service in an AmeriCorps program, regardless of whether or not they completed the previous term(s) of service. MAI is not liable for providing an Education Award to a member if they are not eligible under the Corporation for National and Community Service AmeriCorps guidelines.

Preferred Qualifications:

1. Experience working with a diverse team.
2. Basic knowledge of land management practices.
3. Motivated and able to work independently or with a team.
4. Experience using and tools/equipment.

Member Benefits Include:

5. A total taxable living allowance (before taxes) of \$13,500, paid over term of service.
6. Upon successful completion of a term of service, eligible members receive an education award of \$6,095. The education award can be used to repay qualified student loans, for further education in an accredited institution of higher learning, vocational or trade schools. The education award is taxed in the year that it is used.
7. Loan forbearance (after successful completion of a term of service, AmeriCorps will pay the accrued interest on qualified loans, which is taxable).
8. Basic medical insurance (covers members only, not dependents; vision and dental not included).
9. Child care allowance for those who qualify.
10. VetsWork is an apprenticeship program approved by the Department of Veterans Affairs (VA) and the Department of Labor. Members with G.I. Bill benefits may be able to dual enroll as an apprentice and access their Monthly Housing Allowance (MHA) of up to approximately \$2400 per month. Actual benefits vary by individuals' qualified benefits.
11. Professional development, trainings and networking opportunities.
12. A \$500/month housing stipend is provided by service site.

Transportation Information:

1. Project site is not accessible by public transportation.
2. Agency/Organization vehicles are available for work-related travel.
3. Intern is responsible for travel to and from orientation and to and from duty station.

2. Once you have logged in, create an application by clicking "Applications" under the "My AmeriCorps" menu. Complete the entire application.
3. To apply to this specific position, click "Search Listings" under the "My AmeriCorps" menu and search by program name **Mt. Adams Institute** (this needs to be spelled exactly as listed).
4. Select the position listing: **VetsWork – Mt. Adams Institute – Veterans Only** and click "Apply Now" at the bottom of the page.

Step 2: Submit these additional materials promptly (email preferred). **Your application will not be considered until all of the materials listed below are received.**

1. A resume.
2. A cover letter for each position in which you are interested applying.
3. A copy of your DD 214 with an honorable discharge (general under honorable conditions discharge considered on a case-by-case basis).
4. Visit <https://mtadamsinstitute.org/internships/#vetswork> to print the MAI AmeriCorps Certification Form found under VetsWork Application Documents heading. Sign and date the form with original signature.
5. A copy of your driving record/abstract from your local DMV. Your abstract must go back at least three years, which may mean you need to submit additional abstracts for other states you have been a resident of within that timeframe.

6. Submit your completed MAI Driver Certification and Safety Agreement form found at <https://mtadamsinstitute.org/internships/#vetswork> under VetsWork Application Documents heading.
